*(Under the Nigeria (Electoral Provisions) Order in Council, 1958)*

Establishment of Electoral Districts (Amendment) Proclamation, 1959

In exercise of the powers conferred upon the Governor-General by section 4 of the Nigeria (Electoral Provisions) Order in Council, 1958, I, RALPH FRANCIS ALNWICK GREY, Officer Administering the Government of the Federation as aforesaid, do hereby proclaim that the Establishment of Electoral Districts Proclamation, 1958, is amended by the addition after the first paragraph of the following new paragraph—

"A reference to an Administrative Division in the Schedule to this Proclamation shall mean such Administrative Division as it exists at the date of this Proclamation."

## EXPLANATORY NOTE

This amendment to the Proclamation establishing Electoral Districts for the purpose of Federal elections (Legal Notice 115 of 1958) makes clear that any changes in the areas of Administrative Divisions will not affect the areas on which the Electoral Register has been based.

## LAGOS TOWN PLANNING ORDINANCE (CHAPTER 103)

Ikoyi (South-West) Town Planning Scheme  
(Amendment) Order, 1959

Commencement : 22nd October, 1959

In exercise of the powers conferred by section 24A of the Lagos Town Planning Ordinance, the Lagos Executive Development Board, with the approval of the Governor-General in Council, has made the following Order—

Citation and application.

1. This Order may be cited as the Ikoyi (South-West) Town Planning Scheme (Amendment) Order, 1959, and shall be of application in the Federal Territory of Lagos.

Amendment of Clause 2 of L.N. 164 of 1958.

2. Clause 2 of the Ikoyi (South-West) Town Planning Scheme, 1958, as approved by the Ikoyi (South-West) Town Planning Scheme, 1958 (Approval) Order, 1958, is amended by the deletion from the first line of the third paragraph thereof of the words "plan No. 1029D" and the substitution therefor of the words "plan No. 1029F".

Substitution of new Table of Density Zones, L.N. 164 of 1958.

3. The table headed "Table of Density Zones" in Clause 14 of the said Scheme is deleted and the following substituted therefor—

"TABLE OF DENSITY ZONES"

This amendment revises the layout plan and density zones of the Ikoyi (South-West) Town Planning Scheme as from operational experience of other Schemes the Board has found that 16 plots to an acre is neither practicable nor economic. The layout plan and density zones have therefore been revised to allow a maximum of 12 plots to an acre.

## NIGERIA (NORTHERN CAMEROONS PLEBISCITE)

## ORDER IN COUNCIL, 1959

## Northern Cameroons Plebiscite (Amendment) Regulations, 1959

*Commencement : 22nd October, 1959*

In exercise of the powers conferred by section 5 of the Nigeria (Northern Cameroons Plebiscite) Order in Council, 1959, the Governor-General has made the following regulations—

1. These regulations may be cited as the Northern Cameroons Plebiscite (Amendment) Regulations, 1959 and shall be of Federal application.

2. Regulation 24 of the Northern Cameroons Plebiscite Regulations, 1959, is amended by the addition at the end thereof the following new paragraph—

“(5) Where a returning officer or assistant returning officer is of the opinion that the provisions of paragraph (3) can conveniently be applied in respect of persons employed under him on any duties in connexion with the plebiscite which necessitate their being away on the day of the

plebiscite from the polling stations where they are entitled to vote he may issue in respect of such persons a certificate as in Form 3 set out in the Schedule. The presiding officer in charge of the polling station specified in such form may then issue in exchange for the form a certified extract as set out in Form 4 of the Schedule and the provisions of paragraphs (2), (3) and (4) shall be applied to entitle any such person to vote at the polling station specified in the form issued by the returning officer or assistant returning officer."

3. Form 2 in the Schedule to the same regulations is amended :—  
(a) by the deletion in paragraph 1 of the words "above Polling Station" and the substitution of the following—  
"Polling Station named below" ;  
(b) by the deletion in paragraph 1 of the word "Sex.....".
4. The Schedule to the same regulations is amended by the addition after Form 2 of the two forms set out in the Schedule hereto.
